## TROUBLING INFORMATION

Member of Parliament MP Chong was recently seen to raise the topic of “the information operation” on city television on the Global Television station. The particulars of the statement was not reported extensively, but this was a reminder of how new the term “information” is yet become “relevant” in finding mention across media including the internet on the world wide web. Perhaps reminiscent of the problem of active inner and outer actions which find capability in the common sphere yet recognition by the public sphere, perhaps also called an action of informing, the question of information deserves attention by researchers such that some common understanding could be reached by the public concerning what is desirable and what is not inside of an “information economy.” Of course, the term of the “information economy” was first generated in the 1990’s in conjunction with the large scale offering of the digital computer with the newly expanded digital internet network. However, that other civilizations could not interpret it necessarily the same way, finding that the digital network to be delimited in scope when related to a notion as information was a discovery only later to be made. It would be noteworthy to remark that “creative economy” was proposed concurrently.

## THIN VS THICK

In the adoption of technology in and around America, there are differentials to how much technological applications could be adopted at any given time. Oftentimes, this means that in less abundant regions, the adoption of application is low, while the desire and demand for the outcomes of the tech are raised to levels higher than expected. In this is the distinction from the thick application, which involves the complete acceptance of a tech as an externally founded object with its capacities, and thin adoption of tech, which involves adopting only part or component of the tech, then augmented with various human powered techniques to complete for the outcomes.

In this process of thin adoption, the product then is of lesser quality or quantitative measure, for the thin tech is only working when augmented by actions often by masses of human agents.

The result of thin adoption is not only increased demand and lesser satisfaction, which affects us here on the continent insofar as the reputation of the alleged product. Another outcome is related to the development of the tech in overseas locations where the product cannot be of equivalence to what is being made, marketed, and utilized at home.

## QUESTION OF PIECES AT STAKE

In urban planning, often the distinction is made concerning what constitutes critical infrastructure. Despite that much is considered critical in any city, there are pieces particularly prominent in a city’s running as utilities, banks, health, emergency, and so on. Also important are the state of roads and highways, transportation systems, as well as urban architecture. This last includes the vertical architecture as the newly developed future resource of the glass-cladded skyscrapers and the residential architecture, all of which had been standing on their own in various stages of near-completion. That today additional risks have chanced into the continent means that even our little city of Calgary cannot escape attention. Some have compared the flow of information to a deluge, and despite the shininess of having great abundance, the presence of effective records and legal information, for instance, the message direct from the president to the people, largely remain being called for. One application in the early project pitch stage, called COMMREAL, proposes to have journalists work directly with state stakeholders in America to find the concis and the precis for the people that deserves their time and could aid community action.

Recent events of forest fires in Alberta and neighboring provinces have put many on high alert in apprehending the importance of preparedness and realizing the actualities of readiness for emergency. With additional crises emerging concerning the likelihood of returns and new arrivals on both coast, with the west coast arrivals projected to be earlier, additional avenues are in talks to be made to secure the future of the continent.

The political front remains slow to act, however, business interests now are shifring towards the admittance that readiness could be profitable for when all scenarios find projection, then more commerce could stand to be realized and perhaps at scales large enough that new connections could be made for future business.

The call for a supply chain of essential goods remains on the wire; however, its adoption has been seen as slow to gradual. It is understood that some efforts are ongoing in Central and Mid-West in America, while efforts continue in cities and towns alike to distribute goods to those affected by poverty or migrant activity.
